#### Current Situation

##### Overview:

Immediate evacuations are in place for residents north of Morgan Valley and Bonham Road. The fire is traveling a rapid rate of spread with forward spotting. The terrain is rugged, in heavy brush and timberland. Significant resources are ordered and responding. There are approximately 500 evacuees. An evacuation center is opened at the Highland Senior Center, 3245 Bowers Road, Clearlake. An animal evacuation center is opened at the Lower Lake Social Services parking lot, 15975 Anderson Ranch Parkway, Lower Lake. The fire has destroyed several outbuildings and due to fire activity firefighting crews are focused on attacking the fire. Count of outbuilding will be released later. Primary objectives are public and 1<sup>st</sup> responder safety.
