Current Situation: Fire behavior remained moderate throughout the day and was affected by increased southwest winds. Crews continued to be effective with perimeter control and structure defense. Critical fuel moisture levels, steep terrain, and limited fire access continue to provide challenges. *****Damage Assessment teams continue to collect information in the affected fire areas as access becomes more available*****

Evacuations: (Amador County) Canyon View, Fig Tree Lane, and Ponderosa Way; Tabeau Road south of Arrowhead to Amador Road, Ranch Drive and Aqueduct Grove Road.

(Calaveras County) Town of Mokelumne Hill, east of Hwy 49 from SR 26 south to Goldstrike Road. South on Goldstrike Road to the community of San Andreas. All of SR 26 from Italian Vista, north to the Amador/Calaveras County line, to include the communities of Glencoe, Westpoint, and Wilseyville. Rural areas east of San Andreas to Mountain Ranch Road at Calaveritas Road. Areas east of Calaveritas Road to Fricot Road, and areas north of San Domingo Road to Sheep Ranch Road.

Evacuation Advisory: (Amador County) Hwy 88 from Ranch Road East to Tiger Creek Road (Red Corral and Buckhorn Areas).

(Calaveras County) City of Angels Camp, Hwy 49 south to Hwy 4 south at the city limits of Angels Camp. Hwy 4 north to Sheep Ranch Road, Town of Murphys and Forest Meadows.
