**Current Situation:** Fire behavior remained minimal during the night within the fire perimeter. Favorable weather conditions allowed crews to continue with perimeter control. Firefighters are working aggressively to expedite Re-Populating the affected fire areas. **\*\*\*Damage Assessment teams continue to collect information in the affected fire areas as access becomes more available\*\*\***

**Evacuations:** The areas inside the fire perimeter, South of the Calaveras River.

**Evacuation Advisory:** All areas outside the fire perimeter.

The areas inside the fire perimeter, North of the Calaveras River.

**\*\*\*All previously mandatory evacuated areas being re-populated are still under evacuation advisory. The public is reminded that there are still emergency vehicles and personnel working in the area. Please use caution and remain alert to any changes in fire conditions\*\*\***
