SITUATION				
<b>Current Situation:</b>	Crews continue to make good progress constructing control lines. At 12:00 today, residents in the Communities of Hidden Valley Lake, Jerusalem Grade, Grange Road, and Butts Canyon Road will be allowed to return to their homes. Access to these areas will be allowed to residents only. Hidden Valley Lake will only be accessible through the Hartmann Road entrance. The cancellation of additional evacuation orders are being evaluated based on a variety of factors including potential fire behavior and re-establishment of critical infrastructure. Damage Inspection Teams continue to gather damage data in the affected areas. As additional information becomes available, the numbers of damaged or destroyed structures may change.
