SITUATION				
<b>Current Situation:</b>	Overnight, firefighters made gains mopping up hot spots and strengthening control lines. Today firefighters will continue to construct control lines and repair alterations to the landscape that resulted from earlier suppression operations. The Mandatory Evacuation Order denying access to the communities of North Loch Lomond, Seigler Springs, and Bonanza Springs will be lifted today at 5:00 pm. The cancellation of additional evacuation orders are being evaluated based on a variety of factors including potential fire behavior and re-establishment of critical infrastructure. Damage Inspection Teams continue to gather damage data in the affected areas. As additional information becomes available, the numbers of damaged or destroyed structures may change.
