SITUATION

Current Situation:	Overnight, the fire remained moderate while firefighters continued to build and reinforce containment lines around the fire perimeter. Islands of unburned dry vegetation within the fire perimeter have the potential to burn because of rolling material on steep terrain. Accessibility to the fire is hampered by narrow and congested roads. Weather forecasts are calling for North to Northwest winds to continue, temperatures in the upper 60's, and relative humidity between 40-50 percent. Evacuations:	Santa Clara County: Mandatory evacuation orders for the Loma Prieta ridgeline area including all tributary roads along Summit Road from Soquel San Jose Road to Ormsby Fire Station. This includes Uvas Canyon County Park, Loma Chiquita, Casa Loma, and Loma Prieta Way. Portions of Croy Road are under an evacuation warning.
