SITUATION

Current Situation:	The fire is in steep, inaccessible terrain and with 100+ degree temperatures along with down canyon winds forecasted for the next several days are making firefighting efforts challenging. Firefighters continue to strengthen and build containment lines around the fire. The fire is burning in a mix of grass, brush, and timber litter that are extremely dry with short range spotting. Ground crews, with air support, continue to actively engage in suppressing spot fires around the southern perimeter of the incident.
Evacuations:	Evacuation orders are in place for Lumpkin Road at Onyett/Kanaka Ranch Road to CAL FIRE Station 51, including the community of Feather Falls. Evacuation warnings are in place for the community of Forbestown, south of the South Fork of the Feather River. All residents east of Forbestown Road at the north end of Lower Forbestown Road. All residents north of the intersection of New York Flat Road at Lower Idlewood Circle. All residents north of the intersection of Challenge Cutoff Road at Mt. Hope Road. And all residents west of the intersection of Forbestown Road at Abernathy Road. All areas and residences on Lumpkin Road from Forbestown Road east to Onyett/Kanaka Ranch Road (Grange Hall).
