CURRENT SITUATION

Situation Summary:	The fire burned very actively throughout the day in the Spring Valley area, north east of Clearlake Oaks in Lake County. The fire is being driven by low relative humidity, erratic winds, and above normal temperatures. Expanded evacuation orders are in effect for the entire Spring Valley area and residents are reminded to heed all evacuation orders. Additional resources are en route to the incident.
Evacuations:	Mandatory evacuation orders are in effect for the entire Spring Valley community which includes all roads accessed off of Old Long Valley Road and New Long Valley Road north of Highway 20. Areas also include Mule Skinner, Long Branch, Watertrough Rd, Flintlock, Muzzleloader, No Guns, Antelope, Cougar, Marianne, Ramrod, and Moccasin. An evacuation advisory warning has been issued for east of Walker Ridge area, Wilbur Springs area, Bear Valley, and Brim Road.
