## CURRENT SITUATION

<b>Current Situation:</b>	The County Fire continued to burn actively throughout the night. The fire growth was driven primarily by steep terrain and dry vegetation. Firefighters continued to work through the night to construct new containment lines and defend structures threatened by the fire.

<b>Evacuation Advisories</b>	<ul style="list-style-type: none"> <li>• North of Quail Canyon Road</li> <li>• South of Highway 128</li> <li>• East of the Blue Ridge mountains</li> <li>• West of Pleasants Valley Road</li> <li>• East of Capell Valley Road</li> <li>• North of State Highway 128 from Capell Valley Road, East to the Napa County line</li> </ul>
<b>Road Closures:</b>	<ul style="list-style-type: none"> <li>• Northbound County Road 87 from Highway 128</li> <li>• Berryessa Knoxville Road, from the Pope Creek Bridge to the Napa/Lake County line</li> </ul>

<b>Road Closures Continued:</b>	<ul style="list-style-type: none"> <li>• Pleasants Valley Road, South from Highway 128 remains open to serve traffic into Solano County</li> <li>• Eastbound Highway 128 at Markley Resort</li> <li>• Westbound Highway 128 at Pleasants Valley Road</li> </ul>
