CURRENT SITUATION

Situation Summary:	Safety is a priority as Firefighters continued to secure and construct containment lines throughout the day. Firing operations in the interior of the fire continued as favorable conditions allowed. In less active areas of the fire, mop up, suppression repair and patrol continued. Steep terrain, dry vegetation, and variable winds due to the proximity of the lake have challenged firefighting efforts. Smoke over the area has reduced visibility and moderated fire activity.
