CURRENT SITUATION		
Situation Summary:	Firefighters continue to battle the River and Ranch fires. Crews worked throughout the night to reinforce containment lines. Weather conditions will continue to challenge firefighters as hot, dry and windy conditions persist. A lack of available suppression and overhead personnel will also slow the firefighting efforts.
