## CURRENT SITUATION

*(Recent updates are posted at the top of Current Situation)*

Update August 16, 2012 6:13 a.m. - The fire is now 60% contained, still 2,681 acres. Update 7:32 p.m. - The fire is currently 2,681 acres and 40% contained. Changes in acreage due to more accurate mapping. Full containment expected at 0800, August 18th, 2012. Update 5:33 p.m. - Effective at 6:00 p.m. all mandatory evacuation orders will be lifted, however residents will need to show proper identification to return to residences. Also effective at 6:00 p.m. - the evacuation center will be shut down. Injury Update: A total of five injuries thus far: One civilian with major injuries (transported by air ambulance), one civilian with minor injuries (transported by ground ambulance) and three firefighters with minor injuries (all transported by ground ambulance) Update 12:00 p.m. - CAL FIRE Investigators determined the cause of the fire to be lightning. Additional updates will be posted as information becomes available. Update 08/15/2012 8:05 a.m. - Fire remains at 3000 acres and 15% contained. A significant augmentation of firefighters, fixed-wing, rotor wing and ground resources remain assigned to the incident. CAL FIRE

Incident Command Team 6 will be assuming command of the fire this morning. The Incident Command Post has been relocated to Domenigoni Parkway and Searl Parkway. Evacuation orders for residents on Stanley Rd. Checkmate Rd., Reed Valley Rd., and Garrett Rd. remain in effect. The evacuation center remains open at the Temecula Community Recreation Center at 30875 Rancho Vista Rd. This post is the most current information. All other updates will be posted as significant activity warrants throughout the day. Update August 15, 2012, 5:22 a.m. - The fire is now 15% contained, still 3,000 acres. Approximately 400 firefighters are currently on scene. An Information Officer is available for media interviews at the new Incident Command Post. Update 10:36 p.m - The fire is now 3,000 acres, still 5% contained. There were a total of 32 of 47 homes evacuated. Update 9:45 p.m.: One civilian will transported by air ambulance for treatment of serious burns. Update 8:25 p.m. - Two firefighters were transported with minor injuries to an area hospital. A total of four structures were destroyed. No new update on acreage or containment - Information Officer on scene. Additional updates are immediately posted as information is available from the incident. Update 6:27 p.m. - Riverside Emergency Animal Rescue System (R.E.A.R.S.) is helping to evacuate animals (large and small) at 581 South Grand Avenue, San Jacinto 92582. Update 6:05 p.m. - Update per Incident Commander, fire is 1800 acres and 5% contained. Update 5:55 p.m.: Fire is now 600 acres. Significant augmentation of ground and air resources. approximately 9 homes were evacuated on Stanley Rd., Garrett Rd. , Checkmate Rd. and Reed Valley Rd. Update 3:18 p.m. - There are three confirmed structures damaged. No injuries reported to firefighters or civilians. Information Officer will be on scene shortly. will be on scene shortly. Updates will be posted as information becomes available. Update 2:30 p.m.: Fire is now approximately 50 acres. Mandatory evacuations have been ordered for residents north of Sage Road, South of Stanley Road, East of Benton Road and West of Reed Valley Road. An evacuation center has been opened by the American Red Cross at the Community Recreation Center, located at 30875 Rancho Vista Road in Temecula.
