Current Situation: Additional evacuations are now in effect for Canyon View Loop north of Hwy. 36. Ponderosa Sky Ranch and Lassen Lodge are not immediately threatened. The fire continues to burn in an east and northeast direction in the Battle Creek drainage and into the Blue Ridge area. Steep and rugged terrain is limiting equipment access to critical areas of the fire lines. Firefighters are working aggressively to build and strengthen containment lines. As additional resources arrive, firefighters continue to diligently defend structures, construct containment lines and build bulldozer perimeter lines.

Highway 36 is closed from Dale's Station/Manton Road to Lassen Lodge.

Manton School, Black Butte School in Shingletown, and Plum Valley Elementary School in Paynes Creek have been closed until further notice.

Evacuations: Canyon View Loop, Forward Road at Graham Road to C Line; Forward Mill Road from Rock Creek to Forward Camp Road, Rock Creek Road from Manton to Long Hay Flat Road; All of Long Hay Flat Road; All of Woodcutter Way, Hazen Road area, and South Power House Road, South of Manton. Highway 44 at Brush Oak; East to and including Viola, Plateau Pines, Starlight Pines & McCumber; The south side of Hwy 44 from Viola to Brush Oak and on the north side of Hwy 44 from Viola to Alward.

An **Evacuation Warning** was issued to the residents in the area of Hwy 36 at Oasis Springs Road to Lassen Lodge on both sides of the Highway, which includes Ponderosa Sky Ranch and Lassen Lodge of potential threat to life and property. An evacuation warning considers the probability that an area will be affected and prepares people for a potential evacuation order.

Evacuation Center: The Red Cross Shelter is open at Big League Dreams, 20155 Viking Way, Redding.
